Dear Mr. Koelmo:

Please find enclosed certified copy of Writ of Election issued by Governor Anderson under date of 4 June, 1952 calling for an election to fill a vacancy in the office of State Senator.

Section 205.12 M.S.A. provides that you may place the candidates for the office of Senator in Legislature 3rd Legislative District upon the regular Primary and General Election Ballots. I, therefore, suggest that you prepare the office heading for this office as follows:

FOR SENATOR IN LEGISLATURE 3RD LEGISLATIVE DISTRICT  
(Special Election to fill vacancy in term expiring January 4, 1955)

The State Legislature convenes on the first Tuesday after the first Monday in January of each odd numbered year and, therefore, the term extends to such date in 1955 as above shown in the suggested ballot heading.

May I also call your attention to the provision of Laws of Minnesota 1951, Chapter 323 that provides for the placing of the names of candidates for nomination for State Senator and Representative in the Legislature at the top of respective ballots, namely, for the Primary the ballot of candidates to be Nominated Without Party Designation and on the General Election County and District Ballot.

Writ of election providing for filling the vacancy in the office of State Senator from the third senatorial district of the state at the general election on November 4, 1952, and providing for the nomination of candidates for said vacancy at the regular primary election to be held on September 9, 1952.

To the people of the State of Minnesota, and particularly of the third senatorial district of said state, to the Secretary of State of the State of Minnesota, to the County Auditor of the County of Wabasha in said state, and to all election officers in the third senatorial district, and of all of the several election districts therein, and to all others whom it may concern:


WHEREAS a vacancy now exists in the office of State Senator from the third senatorial district of the State of Minnesota caused by the death of the Honorable James A. Carley; and

WHEREAS there will be occasion for the person elected to fill said vacancy to take office and to exercise the functions thereof at the next regular session of the state legislature;

NOW, THEREFORE, I, C. ELMER ANDERSON, AS GOVERNOR OF THE STATE OF MINNESOTA, acting under the authority and direction of Section 17 of Article IV of the Minnesota Constitution and the statutes in such case made and provided, do hereby direct that said vacancy be filled at the general election to be held in said district on November 4, 1952, and that candidates for said office be nominated at the regular primary election appointed by law to be held in said district on Tuesday, September 9, 1952; that affidavits of candidacy for nomination at said primary may be filed on and between the 11th day of June, 1952, and the 21st day of July, 5:00 P.M., 1952, both dates inclusive; that notices of said primary election


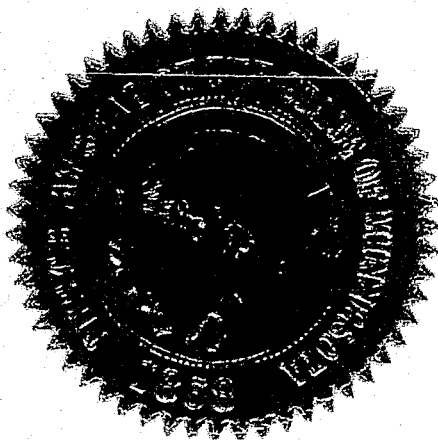
and the said election thereafter be given, posted, and published as prescribed by law; and that the nomination and election of candidates and the conduct of said elections be had, and all things pertaining thereto be done, as provided in Sections 205.05 to 205.17, Minnesota Statutes 1949, and other applicable provisions of law.


