Ordinance No. 52-17

AN ORDINANCE ANNEXING CERTAIN LAND TO THE VILLAGE
OF CRYSTAL.

THE VILLAGE COUNCIL OF the Village of Crystal ordains:

Section 1. All of the owners of the land hereinafter described, having petitioned the Village Council to have such land included within the Village of Crystal, and it appearing that said property abuts on the Village of Crystal; that it is not included in any other village or in any city or borough; that it is so conditioned as to be properly subjected to village government; that it is platted and contains no resident population; and the village council having determined that the annexation of said property will be to the best interests of the village and of the territory affected, it is hereby declared that:

All of Murray Lane 3rd Addition, according to the plat thereof on file and of record in the office of the Registrar of Titles in and for said Hennepin County,

be and the same is hereby annexed to the Village of Crystal.

Section 2. A certified copy of the Petition filed in the Clerk's office and this Ordinance shall be filed by the Clerk in the office of the County Auditor of Hennepin County, Minnesota and another certified copy of said Petition and Ordinance shall be filed by him in the office of the Secretary of State.

Section 3. This Ordinance shall be in full force and effect from and after its passage and publication, and the filing of the certified copies of the documents as required by law.
