

AN ORDINANCE TO EXTEND THE BOUNDARIES OF  
THE VILLAGE OF EXCELSIOR AND INCORPORATE  
ADDITIONAL TERRITORY THEREIN.

The Village Council of the Village of Excelsior ordains:

SECTION 1. Village Boundaries Extended. Pursuant to a petition duly signed by all the owners of land abutting on the Village of Excelsior, Hennepin County, Minnesota described as follows:

Lots One (1), Two (2), Three (3), Sixteen (16), and Seventeen (17), "Galpin Hill Addition, Hennepin County, Minnesota", according to the plat thereof on file and of record in the office of the Register of Deeds in and for Hennepin County, Minnesota.

the territorial limits of the village are hereby extended to include the above described land within its said limits and the aforesaid lands shall hereafter be a part of the village and shall be governed as other territory of the village is governed.

SECTION 2. Certified Copies to be filed. The Clerk is hereby directed to file a certified copy of this ordinance in the office of the Auditor of Hennepin County, Minnesota and in the office of the Secretary of State of the State of Minnesota.

SECTION 3. Effective date. This ordinance shall take effect from and after its passage and publication and the filing of said certified copies as aforesaid.


