Section 33 (j). Auxiliary Fund.

After the city council has allocated annually from the (j) General Fund the amounts, not exceeding the maximum provided in this section, to the Water and Light Fund, Library Fund, Band Fund, Cemetery Fund, Firemen's Relief Fund, and Permanent Improvement Fund, all of the receipts from the annual levy for the General Fund in excess of \$44,000.00, if any, excluding the amount levied under laws of Minnesota for 1951, Chapter 539, (increased cost of living purpose) shall be placed in this Auxiliary Fund, to be used for no other purpose except to help to provide the General Wund for general corporation purposes annually \$44,000.00, excluding income received by virtue of Laws of Minnesota, 1951, Chapter 539, until the amount in this Auxiliary Fund is exhausted, providing, however, that all money accumulated in this fund up to August 1, 1952, shall be transferred by majority vote of the city council to the General Fund to be used only for black-topping (bituminous) streets and avenues, street lights, fire alarm system and extending electric lights and electric power to and in any new platted addition to the city.

The foregoing proposed amendment to Section 33 (j) of the City Charter of the city of Biwabik shall take effect and be in full force and effect two days after the same shall be adopted, certified, deposited and recorded as provided by law.

All sections, or parts of sections, of the said city charter, including Section 33 (j) thereof, inconsistent with the provisions of this amendment and section are hereby repealed.
