## AN ORDINANCE EXTENDING THE CORPORATE LIUTMS OF THE ORYX OP STAPLES AMD THCORPORATIVG ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

Section 1. Pursuant to a petition duly signed by a majority of the owners of the following described property, who are also the owners of more than $51 \%$ of such property: and which property is platted into lots and block and is suitable for municipal government, and which property abuts upon and is adjacent to the City of Staples, Todd County, Minnesota, and which property is described as follows, to-wit:

Lots Seven (7), Hight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12) of Block one (1), and Lots Seven (7), EIGht (8), Nine (9), Ten (10) Eleven (11) and Twelve (12) of Block Two (2), all in Wilson's First Addition to Staples,
