ORDINANCE NO. 16

AN ORDINANCE ANNEXING LAND TO THE VILLAGE OF
DELLWOOD, MINNESOTA

WHEREAS, The owner of the tract of land hereinafter described has petitioned the Village Council of the village of Dellwood, Minnesota, to have such land included within the said village; and,

WHEREAS, The Village Council has determined and does hereby determine, that the annexation of said land will be to the best interests of the village, and of the territory affected,

NOW THEREFORE, THE COUNCIL OF THE VILLAGE OF DELLWOOD DO ORDAIN AS FOLLOWS:

1. The following described tract of land lying and being in the County of Washington, State of Minnesota, to-wit:

All that part of the Northwest Quarter (N.W. $\frac{1}{4}$) of the Northwest Quarter (N.W. $\frac{1}{4}$) of Section number Seventeen (17), in Township number Thirty (30) North of Range number Twenty-one (21) West of the Fourth Principal Meridian lying Northerly of the center line of Stillwater Road,

is hereby declared to be annexed to the village of Dellwood, Minnesota, and is hereby included within the limits of said village.

2. The village clerk is hereby directed to file a certified copy of this Ordinance in the office of the County Auditor of Washington County, Minnesota, and another certified copy of the Ordinance in the office of the Secretary of State of the State of Minnesota.

3. This ordinance shall take effect and be in force from and after its passage and publication, and the annexation of said land shall be complete, and the land shall be a part of the village upon the filing of the certified copies with the County Auditor and the Secretary of State.
