AN ORDINANCE DETACHING CERTAIN LAND FROM THE VILLAGE OF CRYSTAL.

The Village of Crystal Ordains:

Section 1. All of the owners of the land hereinafter described, having petitioned the Village Council to have such land detached from the Village of Crystal, and it appearing that it is unplatted land situated within the corporate limits of this village but adjacent to the village boundary and occupied and used solely for agricultural purposes, it is hereby determined that said property shall be detached from the village of Crystal, the same being legally described as follows:

That part of the Southeast Quarter of the Northwest Quarter of Section 5, Township 118, North Range 21, West of the Fifth Frincipal Meridian, Hennepin County, Minnesota described as follows: Beginning at a point on the East line of said Southeast Quarter of the Northwest Quarter of said Section 5, distant 1025 feet North of the Southeast corner thereof; thence North 296.6 feet, more or less, to the Northeast corner of said Southeast Quarter of the Northwest Quarter of said Section 5; thence West along the North line of Southeast Quarter of Northwest Quarter of said Section 5, a distance of 78.2 feet; thence South, a distance of 296.6 feet, more or less, to a point which is due West from the point of beginning; thence East, a distance of 78.2 feet, more or less, to the point of beginning.

Section 2. A certified copy of the petition filed in the Clerk's office and this Ordinance shall be filed by the Clerk in the office of the County Auditor of Hennepin County, Minnesota and another certified copy of said petition and Ordinance shall be filed by him in the office of the Secretary of State.

Section 3. This Ordinance shall be in full force and effect from and after its passage and publication, and the filing of the certified copies of the documents as required by law.
