We the Village Council of the Village of Frost hereby certify to the County Auditor and to whom it may concern that at the special election of the Village of Frost in the county of Faribault and State of Minnesota, held at the Rendahl's Hall being the place where it was directed to be held by the Village Council after giving due notice thereof as provided by law, on the 10th day of February 1914,

A.A. Erdahl and O. L. Underdahl two qualified voters of said Village, to act as Judges of such Election, and one qualified voter of said Village to act as Clerk of such Election, each of whom had within twenty days before such time been designated and appointed by the Village Council to act as Judges and Clerk respectively of such Election, who being present, at the hour of 9 o'clock A.M., each of them duly took and subscribed and oath to faithfully discharge the duties required of them at such Election, and the said Judges and Clerk being duly qualified, forthwith opened the polls by proclamation, and the Election proceeded by ballot without adjournment or intermission until closed.

The subjects voted on at such Election as stated in the Notice thereof, were:

Shall the Village of Frost, Faribault county, Minnesota be constituted a separate assessment and election district and be separated from the Townships of Rome and Emerald for assessment and election purposes.

At 6 o'clock in the afternoon of said day the polls were closed, proclamation thereof having been made by one of the Judges thirty minutes previous thereto. The Judges then proceeded to publicly count and canvass the votes, and a true statement thereof was duly proclaimed to the voters by the Clerk, who recorded the same in the Village Minute Book.

STATEMENT OF RESULT OF CANVASS.

The following is a true statement of the result of the counting and canvass of votes by ballot at the special Election of the Village of Frost, County of Faribault, and State of Minnesota, held February 10th 1914, as proclaimed to the voters by the Clerk of Election:

And we further certify that it was then and there voted that the Village of Frost, Faribault County, Minnesota, be constituted a separate assessment and election district and be separated from the Townships of Rome and Emerald for assessment and election purposes, by a majority of the electors of the Village of Frost casting the ballots upon such question at the special election called for that purpose, the notice of whereof was plainly submitted; that this ^{affidavit} ~~affidavit~~ is made to comply with the requirements of sections ¹²³⁸ ~~1, 2, 3, and 8~~ General Statutes of Minnesota for the year 1913, and the County Auditor is requested to certify same to the Secretary of State.


