ORDINANCE

AN ORDINANCE annexing to the Village of Funkley, Minnesota, pursuant to M.S.A. 412.041, Subd. 4.

WHEREAS, the territory in the County of Beltrami, State of Minnesota, described as follows, to wit:

~~All of the South one-half of Northwest one quarter (SW $\frac{1}{4}$) of Section 24;~~
Southeast one quarter of Northeast one quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 24;
Northeast one quarter of Southeast one quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 24;
North one-half of Southeast one quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$) of Section 25; South-
west one quarter of Southeast one quarter (SW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section 25,
township one hundred fifty (150), range thirty (30).

WHEREAS, said territory is so conditioned as properly to be subjected to the village government and is not included in any other village, city or borough, and

WHEREAS, all of the owners of said lands have petitioned this council to have such land included within the Village of Funkley, Minnesota and

WHEREAS, the council has determined that such annexation will be to the best interest of the Village of Funkley, Minnesota and of the territory affected:

NOW, therefore, be it ordained by the Village Council of the Village of Funkley, Minnesota, that the territory in the County of Beltrami, State of Minnesota, described as follows, to wit:
