

ORDINANCE NUMBER 1.

AN ORDINANCE EXTENDING THE BOUNDARIES OF THE VILLAGE OF ZEMPEL IN ITASCA COUNTY, MINNESOTA, TO INCLUDE A TRACT OF LAND ADJOINING SAID VILLAGE SITUATED IN THE SOUTH HALF OF SOUTHWEST QUARTER OF SOUTHEAST QUARTER (3/4 of SW 1/4 of SE 1/4) OF SECTION THIRTY-SIX (36) IN TOWNSHIP ONE HUNDRED FORTY-FIVE (145), RANGE TWENTY-NINE (29),

THE VILLAGE COUNCIL OF THE VILLAGE OF ZEMPEL, ITASCA COUNTY, MINNESOTA, DO ORDAIN AS FOLLOWS:

WHEREAS, Deer River Manufacturing Company is the sole owner of the undivided land herein described, abutting upon said Village of Zempel, and exceeding by one hundred (100) acres so that the council to have jurisdiction and included within the Village, which jurisdiction has been granted;

Be it therefore enacted and ordained:

SECTION 1. That the boundaries of said Village be and the same hereby are extended to include and that said Village include the following described land abutting upon said Village, to-wit: That part of the southeast quarter of southwest quarter (SE 1/4 of SW 1/4 of SE 1/4) of Section thirty-six (36), in Township One Hundred Forty-five (145) North, of Range Twenty-nine (29) West, of Fifth Principal Meridian (5th P.M.), in Itasca County, Minnesota, bounded and described as follows:

Commencing at the southeast corner of said southwest quarter of southeast quarter (SW 1/4 of SE 1/4) thence north on the east boundary of said subdivision thirty (30) rods, thence west on the line parallel with the north and south boundaries of said subdivision to a point on the west boundary line of said subdivision, thirty (30) rods north of the southwest corner of said subdivision, thence south on said west boundary line to said southwest corner of said subdivision, thence east on the south boundary line of said subdivision to the point of beginning, said tract of land containing fifteen (15) acres, more or less.

SECTION 2. That this ordinance shall be in and take effect on its publication and the filing of a certified copy thereof in the office of the Secretary of State of Minnesota.
