KNOW ALL MEN BY THESE PRESENTS That,

WHEREAS, former Attorney General of the State of Minnesota, J.A.A. Burnquist, under date of January 18, 1954, duly appointed Richey B. Reavill as Special Assistant Attorney General for the State of Minnesota to bring an action or actions to quiet title or registration proceedings as to the following described lands:

all in Section Twenty-nine (29), Township Fifty-nine (59) North, Range Fourteen (14) West, St. Louis County, Minnesota (State Lease No. T-5014).

Three-fourths ($3/4$ ths) interest in and to the minerals in the Southeast Quarter (SE/4) of the Northwest Quarter (NW/4), and

Seven-eighths ($7/8$ ths) interest in and to the minerals in Lot Two (2) or the Southwest Quarter (SW/4) of the Northwest Quarter (NW/4), and

Seven-eighths ($7/8$ ths) interest in and to the minerals in Lot Three (3) or the Northwest Quarter (NW/4) of the Southwest Quarter (SW/4), and

Sixty-five seventy-seconds (65/72nds) interest in and to the minerals in Lot Four (4) or the Southwest Quarter (SW/4) of the Southwest Quarter (SW/4)

all in Section Thirty (30), Township Fifty-nine (59) North, Range Fourteen (14) West, St. Louis County, Minnesota (State Lease No. T-5015).

Thirty-four fortieths (34/40ths) interest in and to the minerals in the Southeast Quarter (SE/4) of the Southeast Quarter (SE/4) of Section Twenty-eight (28),

Thirty-four fortieths (34/40ths) interest in and to the minerals in the North one-half (N/2) of the Northeast Quarter (NE/4) of Section Thirty-three (33), and

Thirty-four fortieths (34/40ths) interest in and to the minerals in the Northeast Quarter (NE/4) of the Northwest Quarter (NW/4) of Section Thirty-three (33),

all in Township Fifty-nine (59) North, Range Fifteen (15) West, St. Louis County, Minnesota (State Lease No. T-5016).

Whole interest in the West one-half (W/2) of the Northeast Quarter (NE/4) of Section Thirty (30), Township Fifty-nine (59) North, Range Fourteen (14) West, St. Louis County, Minnesota (State Lease No. T-5021).
