KNOW ALL MEN BY THESE PRESENTS that I, MILES LORD,  
Attorney General of the State of Minnesota, by virtue of the  
authority vested in me by statute, and particularly by M. S. 1953,  
§ 8.06, do hereby constitute and appoint

ROBERT J. PHILLIPS

to be a Special Assistant Attorney General, on request of the Ad-  
jutant General of Minnesota, in the matter of the acquisition of  
lands for military purposes as authorized by Laws 1951, Chapter  
511, examining titles to real estate involved, handling such con-  
demnation proceedings as may be required, supervising the gathering  
of field information, and performing such other duties as may be  
necessary in connection therewith. His compensation shall be paid  
by the Adjutant General out of funds appropriated to the latter as  
provided in Laws 1951, Chapter 511. Said compensation is hereby  
fixed at Thirty Dollars (\$30.00) per day and necessary mileage at  
the legal rate for services rendered as disclosed by statements,  
submitted twice a month, showing number of hours engaged in doing  
the work together with a list of work performed. The compensation  
so fixed shall continue until otherwise determined. Said appointee  
shall serve at the pleasure of the Attorney General or until this  
appointment shall be revoked or otherwise terminated in accordance  
with law.
