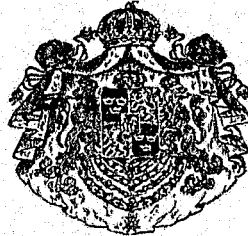

Göre veterligt att som VI till befrämjande af de emellan Sverige och Amerikas Förenta Stater redan bestående vänskaps- och handels- förhållanden, för godt och nödigt funnit att utnämna och förordna KARL EDVARD WALLERSTEDT till konsul i Minneapolis med distrikt omfattande staterne Montana, North-Dakota, South-Dakota, Minnesota, Nebraska, Colorado, Wyoming, och New Mexico. Altså vilja VI härmed, och i kraft af VÅRT öppna Bref i Nåder hafva utnämnt och förordnat honom till denna tjänst. Och då VI äro öfvertygade därom, att FÖRENTA STATERNAS REGERING behagar emottaga och erkänna honom uti denna egenskap, är härmed VÅR vänliga begäran till hvar och en, särskildt till ämbetsmyndigheterna uti den Stat, hvarest han blivit anställd, att de med förtroende och välvilja måtte lämna honom den hjälp, hvaraf han till tjänstens förrättande kan vara i behof, anbefallande VI VÅRE egne undersåter att bevisa honom den aktning och lydnad, hvartill han, enligt gällande Lagar och Författningar samt den af OSS utfärdade Konsulat-Förordning, är berättigad. Till yttermera visso hafva VI detta med Egen hand underskrifvit och med VÅRT Kungl. Sigill bekräfta låtit.

Satisfactory evidence having been exhibited to me that Carl Edvard Wallerstedt has been appointed Consul of Sweden at Minneapolis, Minnesota, for the States of Colorado, Minnesota, Montana, Nebraska, New Mexico, North Dakota, South Dakota, and Wyoming, I do hereby recognize him as such, and declare him free to exercise and enjoy such functions, powers and privileges as are allowed to Consuls by the law of Nations, or by the laws of the United States and existing treaty stipulations.
