

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF ROSEMOUNT, MINNESOTA AND DECLARING SAID LANDS TO BE AN ADDITION TO SAID VILLAGE.

The Village Council of the Village of Rosemount, Minnesota Ordains as follows:

Section 1. That the following described real estate, situated in the County of Dakota, State of Minnesota, owned by the Village of Rosemount, Minnesota, and abutting upon and contiguous to said Village, is hereby annexed to the Village of Rosemount and declared to be an addition thereto:

All that part of the Northwest quarter of the Southeast quarter (NE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 20, Township 115 North, Range 19 West, described as follows: Commencing at a point on the South line of said $\frac{1}{4}$ section where it intersects the West right-of-way line of the Chicago, Milwaukee and Saint Paul Railway Company, said point being 350 feet West of the Southeast corner of said $\frac{1}{4}$ section and the point of beginning; thence West on said South line 308 feet to an iron stake; thence North at right angles 350.3 feet to an iron stake; thence East at right angles 555.7 feet to the Westerly right-of-way line of said Railway Company, thence Southwesterly along said right-of-way line to the point of beginning, containing 3.84 acres, more or less, all according to the government survey thereof; also:

All that part of the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 20, Township 115 North, Range 19 West described as follows: Commencing at a point on the South line of said $\frac{1}{4}$ section where it intersects the Westerly right-of-way line of the Chicago, Milwaukee and St. Paul Railway Company, thence Northeast-erly along said right-of-way line 408 feet to an iron stake; thence West parallel to the South line to a point 65 feet West and secured at right angles to said right-of-way line; thence Southwesterly parallel to said right-of-way line 600 feet to the South line of said $\frac{1}{4}$ section, thence East on said line to the point of beginning, containing 0.92 acres, more or less, all according to the government survey thereof; also:

All that part of the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 20, Township 115 North, Range 19 West, described as follows: Commencing at a point on the North line of said $\frac{1}{4}$ section where it intersects the West right-of-way line of the Chicago, Milwaukee and St. Paul Railway Company, thence West on said North line 740 feet to an iron stake, thence South at right angles 775 feet to an iron stake, thence East at right angles 400 feet to the Westerly right-of-way line of said railway company, thence North-esterly along said right-of-way line 349.8 feet to the point of beginning, containing 10.55 acres, more or less, all according to the government survey thereof; also:

All that part of the Southwest quarter of the Southeast quarter (SW $\frac{1}{4}$ of SE $\frac{1}{4}$) and the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$ of SE $\frac{1}{4}$) of Section 20, Township 115 North, Range 19 West, described as follows: Commencing at a point on the North line of said $\frac{1}{4}$ sections where it intersects with the West right-of-way line of the Chicago, Milwaukee and St. Paul Railway Company; thence West on said line 740 feet to an iron stake, this being the point of beginning; thence West on said North line 1155 feet to the Westerly right-of-way of State Highway No. 218 as now established, thence Southwesterly along said right-of-way line to a point 49.5 feet South of said $\frac{1}{4}$ line; thence East parallel to said $\frac{1}{4}$ line and 49.5 feet South therefrom 1170 feet to a point due South of the point of beginning; thence North at right angles 49.5 feet to the point of beginning; containing 1.33 acres, more or less, all according to the government survey thereof.

Section 2. That this ordinance shall take effect from and after

its passage and publication; and that upon the passage, approval and publication of this ordinance the village clerk is hereby directed to cause certified copies hereof to be filed in the office of the County Auditor of Dakota County, Minnesota, and in the office of the Secretary of State for the State of Minnesota.
