

ORDINANCE NUMBER 27

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF HALSTAD TO INCLUDE CERTAIN UNPLATTED LANDS, HEREINAFTER DESCRIBED, LOCATED IN THE NORTHEAST QUARTER OF SECTION THIRTY IN HALSTAD TOWNSHIP, NORMAN COUNTY, STATE OF MINNESOTA.

WHEREAS, A certain petition dated August 12, signed by all of the owners of the hereinafter described property, requesting the annexation of said territory was duly presented to the Council on the 12th day of August, 1955;

The Village Council of Halstad, Minnesota, ordains:

Section 1. DECLARATION. It is hereby determined that the hereinafter described property is unplatted and does not exceed two hundred Acres; that said territory is so conditioned as properly to be subjected to village government; and that the annexation thereof will be to the best interests of the village and of the territory affected.

Section 2. TERRITORY ANNEXED. The corporate limits of the village are hereby extended to include the territory described as follows:

Commencing at the Southeast corner of the Original Townsite of the Village of Halstad, Norman County, Minnesota; thence easterly and parallel with the south line of the Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty (30) in Township One Hundred Forty-five (145), Range Forty-eight (48), Norman County, Minnesota, to the north-south center line of said Northeast Quarter; thence North on said north-south center line to the Northeast corner of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Thirty; thence West on the north line of said Section Thirty to the Northeast corner of Sulerud Bros. First Addition to the Village of Halstad; thence South on the east line of said Sulerud Bros. First Addition to the Northwest corner of Carlson's Addition to the Village of Halstad; thence East on the north line of said Carlson's Addition to the Northeast corner of Carlson's Addition; thence South on the east line of Carlson's Addition to the Southeast corner of Carlson's Addition; thence West on the south line of Carlson's Addition to the Southwest corner of Carlson's Addition; thence South on the east line of Sulerud Bros. First Addition to the South line of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Thirty; thence West on said south line of said Northwest Quarter of the Northeast Quarter to the Southwest corner of the Northwest Quarter of the Northeast Quarter of Section Thirty; thence South on the west line of the Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Thirty to the place of beginning.

Section 3. FILING. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State and in the office of the County Auditor of Norman County, Minnesota.

Section 4. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its publication and the filing of the certified copies as directed
