ORDINANCE NO. 98

An Ordinance Annexing Certain Land Abutting Upon the Village of Mahtomedi and Extending the Village Boundaries to Include the Same.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI TO OBTAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of that certain tract of land, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include said tract of land lying and being in Block Three (3) of East Shore Heights, County of Washington, State of Minnesota, described as follows, to-wit:

Commencing at a point where the center line of Ivy Street (formerly known as Iris Street and also as Herrit Street) intersects the center line of Warner Avenue; thence East along the center line of said Ivy Street to the center line of the ten foot alley running in a Northerly and Southerly direction along the East side of said Lots 10 through 14 in Block 3 of East Shore Heights; thence South along the center line of said ten foot alley to the center line of Hanson Street; thence West along the center line of Hanson Street to the center line of Warner Avenue; thence North along the center line of Warner Avenue to the point of beginning,

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and from and after its publication.
