OLDINANCE NO. 98

An Ordinance Annexing Certain Land Abutting Upon the Village of Mahtomedi and Extending the Village Boundaries to Include the Same.

THE VILLACE COUNCIL OF THE VILLAGE OF MANTANEDI TO OFDAIN AS FOLLO'S:

Section 1. That pursuant to that certain petition signed by all of the owners of that certain tract of land, containing less than two hundred acres, abutting upon the Village of Mahtemedi, requesting the annoxation of said land to said Village, said potition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the village boundaries of the Village of Mahtemedi are hereby extended to include said tract of land lying and being in Block Three (3) of East Shore Feights, County of Tashington, State of Minnesota, described as follows, to-wit:

> Commencing at a point where the center line of Twy Street (formerly known as Tris Street and also as Herrit Street) intersects the center line of darner Avenue: thence East along the center line of said Twy Street to the center line of the ten foot alley running in a Northerly and Southerly direction along the East side of said Lots 10 through 14 in Block 3 of East Shore Heights: thence South along the center line of said ten foot alley to the center line of Hanson Street; thence dest along the center line of Hanson Street to the center line of Warner Avenue; thence North along the center line of Warner Avenue; thence North along the center line of Warner Avenue to the point of beginning.
