ORDINANCE NO. 99

An Ordinance Annexing Certain Land Abutting Upon the Village of Mahtomedi and Extending the Village Boundaries to Include the Same.

THE VILLAGE COUNCIL OF THE VILLAGE OF MAHTOMEDI DO ORDAIN AS FOLLOWS:

Section 1. That pursuant to that certain petition signed by all of the owners of that certain tract of land, containing less than two hundred acres, abutting upon the Village of Mahtomedi, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annexation will be to the best interests of the Village and of the territory affected, the village boundaries of the Village of Mahtomedi are hereby extended to include said tract of land lying and being in Section 20, Township 30 North, Range 21 West, Washington County, Minnesota, described as follows, to-wit:

Commencing at a point on the Easterly boundary line of the Village of Mahtomedi where the Easterly boundary line of the former street railway right-of-way intersects the South line of Lot 10 in Block 11 of Town of Wilson (heretofore vacated); thence Southerly along said Easterly right-of-way line to the center line of Iris Street (formerly known as Woodland Street); thence Easterly along the center line of said Iris Street to the center line of Warner Avenue (formerly known as Fairmount Avenue); thence Northerly along the center line of said Warner Avenue to South line of Lot 10 in Block 11 of Town of Wilson (heretofore vacated), if said South line of said Lot 10 were extended Easterly into Warner Avenue; thence West along the South line of said Lot 10 to point of beginning.

and that said territory is hereby made a part of the Village of Mahtomedi as effectually as if the same had originally been a part of said Village.

Section 2. This Ordinance shall take effect and be in force upon the filing of a certified copy thereof with the County Auditor of Washington County and the Secretary of State of the State of Minnesota and from and after its publication.
