GIVERANCE NO. 99

An Ordinance Annexing Cortain Land Abutting Upon the Village of Mahtemedi and Extending the Village Boundaries to Include the Same.

THE VILLAGE COUNCIL OF THE VILLAGE OF MARTINEZED TO ORDAIN AS FOLICES:

Section 1. That pursuant to that certain petition signed by all of the ewners of that certain tract of land, containing less than two hunared acres, abutting upon the Village of Maintenedl, requesting the annexation of said land to said Village, said petition having been duly filed with the Clerk of said Village; and it appearing that such annoxation will be to the best interests of the Village and of the territory affected, the village boundaries of the Village of Maintenedicare hereby extended to include said tract of land lying and being in Section 20, Termship 30 North, Wange 21 West, Asshington County, Minnesota, described as follows, to-wit:

Commoneing at a point on the Easterly boundary line of the Village of Mahtemedi where the Easterly boundary line of the former street railway right-of-way intersects the South line of Lot 10 in Mack 11 of Town of Mison (herotofore vacated); thence Southerly along said Masterly right-of-way line to the center line of Iris Street (formerly known as Woodland Street); thence Masterly along the center line of said Iris Street to the center line of Marner Avenue (formerly known as Fairmount Avenue); thence Mortherly along the center line of said Marner Avenue to South line of Lot 10 in Block 11 of Town of Milson (heretofore vacated), if said South Line of said Lot 10 were extended Easterly into Marner Avenue; thence West along the South Line of said Lot 10 to point of beginning,

and that said territory is hereby made a part of the Village of mahtemedi as offectually as if the same had originally been a part of said Village.
