**ORDINANCE NO. 49**

**AN ORDINANCE ANNEXING  
REAL PROPERTY TO THE VILLAGE  
OF WESTBROOK, MINNESOTA**

The Village Council of the Village of Westbrook, Minnesota, do ordain as follows:

SECTION 1. That the following described real property situated in the County of Cottonwood and State of Minnesota, be annexed to and made a part of the Village of Westbrook, Minnesota, to-wit: "Commencing at a point on the East Boundary Line of Lot 8 of Interstate Land Company's Outlots to the Village of Westbrook, Minnesota; 185.5 feet North of the Northwest Corner of Lot 9 of Interstate Land Company's Outlots to said Village of Westbrook, FOR A POINT OF BEGINNING; thence due East 660 feet, more or less, to a point of intersection with the East Boundary Line of Lot 10 of Interstate Land Company's Outlots to said Village of Westbrook; if extended and produced in a due Northerly direction; thence Northerly along the East Boundary Line of Lot 10 of said Interstate Land Company's Outlots, so extended and produced, for a distance of 399 feet; thence Westerly 660 feet, more or less, to a point of intersection with the Northeast Corner of Lot 8 of said Interstate Land Company's Outlots; thence Southerly along the East Boundary Line of said Lot 8 of Interstate Land Company's Outlots, for a distance of 399 feet, more or less, to the point of beginning, containing in all, 6.06 acres of land, more or less, according to the Government Survey thereof."

SECTION 2. That the afore described real property shall be included within the corporate limits of the Village of Westbrook, Minnesota.

SECTION 3. This ordinance shall become effective, upon its publication, and the filing of a certified copy thereof, with the Secretary of State for Minnesota, all as provided for by law.
