Introduced by Councilman Albert Mattick.

Seconded by Alderman Alfred Spronger.

1. Whereas, Herbert B. Richter and Barbara Richter, have duly presented to the Village of Gonger a Petition for the annexation of certain lands abutting the Village of Gonger and fully described as follows:-

Beginning at a point, which is 842.13 feet South of the Northwest corner of the NE $\frac{1}{4}$  of section 30, Township 102 North, Range 22 West; thence East 168.5 feet; thence South 75.0 feet; thence West 168.5 feet; thence North 75.0 feet to the point of beginning, subject to highway easements on the West side thereof. Said lands are in the County of Freeborn, State of Minnesota.

2. Said Petition was presented to the Village Council on the 14th day of July, 1955. Said land is not platted, it does not exceed two hundred acres in area. Said petitioners are the sole owners of the land described above and described in the Petition.

Said land abuts and is adjacent to land already in the Village limits of the Village of Gonger.

3. Whereas, it appears to the best interests of the Village and to the territory affected to have said premises annexed to the Village of Gonger.

NOW THEREFORE, said premises described above are hereby declared to be annexed and are hereby annexed to the Village limits of Conger and said land shall be a part of the Village as effectually as if it had been originally a part thereof.

Let a certified copy of this ordinance be filed in the office of the County Auditor for Freeborn County and another certified copy of this ordinance filed in the office of the Secretary of State for the State of Minnesota.

Read the first time on July 14, 1955.

Read the second time and passed, August 2, 1955. Said ordinance passed by unanimous vote of the Village Council.
