AN ORDINANCE ANNEXING THE EAST ONE-HALF (E 1/2) of the NORTHEAST ONE-QUARTER (NE 1/4) of the SOUTHWEST ONE-QUARTER (SW 1/4) of SECTION 13, TOWNSHIP 29, RANGE 22, PLATTED AS "FURNHOLZ ADDITION, RAMSEY COUNTY, MINNESOTA" TO THE VILLAGE OF NORTH ST. PAUL, RAMSEY COUNTY, MINNESOTA.

THE VILLAGE COUNCIL OF NORTH ST. PAUL ORDAINS:

Section 1.

WHEREAS, all of the owners of lands in the East one-half (E 1/2) of the Northeast one-quarter (NE 1/4) of the Southwest one-quarter (SW 1/4) of Section 13, Township 29, Range 22, platted as "FURNHOLZ ADDITION, RAMSEY COUNTY, MINNESOTA" have heretofore, on the 5th day of July 1955 at its regular meeting, petitioned the Village Council to annex said lands to the Village of North St. Paul, and

WHEREAS, the Village Council has, after due study and consideration, determined that said lands are platted lands; the area does not exceed 200 acres; all of the owners of said lands have joined in a valid petition to annex said lands to the Village of North St. Paul; that the annexation of said lands to the Village of North St. Paul, will be to the best interests of the village and the territory affected.

Section 2.

THE VILLAGE COUNCIL DETERMINES: that the lands lying in the East one-half (E 1/2) of the Northeast one-quarter (NE 1/4) of the Southwest one-quarter (SW 1/4), platted as "FURNHOLZ ADDITION, RAMSEY COUNTY, MINNESOTA", be and they are hereby ANNEXED to and become part of the corporate area of the Village of North St. Paul, Ramsey County, Minnesota, upon the adoption and publication of this Ordinance as required by law.

Adopted by the Village Council, this 15th day of August 1955.
