POWER OF ATTORNEY

(d) The President or any of the Vice Presidents shall have power with the concurrence of any of the Secretaries or Assistant Secretaries to appoint and authorize Resident Managers, Bond Superintendents and Field Managers to execute, seal and deliver on behalf of the Corporation unto such person or persons as they may select, its Power of Attorney constituting each such person Attorney in Fact of the Corporation, with full power and authority to execute, seal and deliver for and on behalf of the Corporation, in its name and in its behalf, as surety, one and one only specific bond or undertaking as described in each instance in each such Power of Attorney.

(e) The Attorneys in Fact under subparagraphs (c) and (d) of this Section are authorized and empowered to certify to a copy of any of the By-Laws of the Corporation or any resolutions adopted by its Board of Directors and to the financial statement or other statement of the condition of the Corporation and to affix the Seal of the Corporation thereunto. does hereby nominate, constitute and appoint A. X. Johnson of Wayzata, Minnesota its true and lawful attorney(s) in fact, with full power and authority hereby conferred to make, sign, execute, acknowledge and affix the Corporate Seal of the Corporation, as Surety, as its act and deed, subject to the limitations and conditions hereinafter set forth, bonds and undertakings as follows: Any and all bonds and undertakings of suretyship provided the penal sum of no one bond shall in any event exceed ONE HUNDRED THOUSAND (\$100,000) DOLLARS. and to bind ATNA INSURANCE COMPANY thereby as fully and to the same extent as if such bond was signed by the duly authorized officers of ÆTNA INSURANCE COMPANY, and all the acts of said attorney(s), pursuant to the authority herein given, are hereby ratified and confirmed.
