WRIT OF OUSTER

THE STATE OF MINNESOTA TO THE VILLAGE OF SPRING PARK AND ITS DULY  
ELECTED OR ACTING OFFICIALS:

WHEREAS, upon consideration of the writ of quo warranto  
issued herein on March 29, 1955, to which you have made return, and  
this court having on November 17, 1955 filed its order directing that  
a writ of ouster issue;

NOW THEREFORE, you, the Village of Spring Park and your  
duly elected or acting officials are hereby ousted from exercising any  
jurisdiction over a certain tract of land described as follows, to-wit:

That land lying east and south of present  
easterly village limits of the Village of  
Spring Park as follows: Lots 1, 2 and 3,  
Streater's Spring Park Addition, Block 4;  
lots 1, 2 and 3, Streater's Spring Park  
Addition, Block 5, together with unnumbered  
lot directly east of above mentioned lots  
and joined on the east by lots 1 and 2, Town-  
site of Langdon Park, Block 9, and including  
lots 1 and 2, Block 9; Lots 1 through 12,  
Townsite of Langdon Park, Block 8, and Lots  
1 and 2, Townsite of Langdon Park, block 7  
Hennepin County, Minnesota.

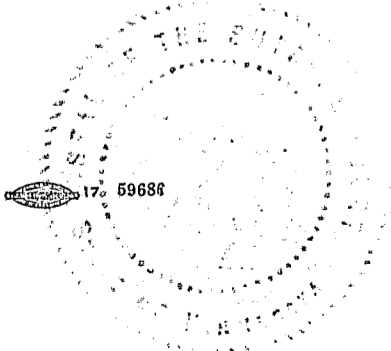
