

ORDINANCE NO. 2 5 6

AN ORDINANCE TO ANNEX CERTAIN PROPERTY TO THE CITY OF WORTHINGTON,
MINNESOTA

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW, WHEREAS, pursuant to Section 413.14, and all amendments thereto, of Minnesota Statutes for 1941, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City; and

WHEREAS it is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to wit,

That part of the Southwest Quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 13, Township 102 North, Range 40 West, in the County of Nobles and State of Minnesota, described as follows; to wit,

Commencing at a point on the Section line between Section 13 and Section 24, Township 102 North, Range 40 West, 70 feet West and 33 feet South of the Southwest corner of Lot 8 of the Plat of North Worthington; thence north and parallel with the West line of Lot 8 of the Plat of North Worthington, a distance of 258 feet; thence West and parallel with the South line of said Section 13, a distance of 115 feet; thence South and parallel with the West line of said Lot 8 of the Plat of North Worthington, a distance of 258 feet to the south line of Section 13; thence East on the South line of Section 13, a distance of 115 feet to the point of beginning.
