

ORDINANCE NO. 259

AN ORDINANCE TO ANNUK CERTAIN PROPERTY TO THE CITY OF WORTHINGTON, MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW, WHEREAS, pursuant to Section 413.14, and all amendments thereto, of Minnesota Statutes for 1941, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City; and

WHEREAS it is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to wit,

That part of the Southeast Quarter of the Southeast Quarter (SE4 SE4) of Section 14, Township 102 North, Range 40 West, in the County of Nobles and State of Minnesota, described as follows; to wit, Commencing at a point on the section line between Sections 14 and 23, Township 102 North, Range 40 West, lying directly North and 339 feet West of the Northeast corner of Lot 1, Block 1 of Auditor's Plat of Benson's Addition to the City of Worthington in said County and State; thence North at right angles to the section line, a distance of 358 feet; thence West at right angles, 95 feet; thence South at right angles, 358 feet; thence East along said section line, 95 feet to the point of beginning.

Also, that tract of land located in the Southeast Quarter of Southeast Quarter (SE4 SE2) of Section 14, Township 102 North, Range 40 West, in the County of Nobles and State of Minnesota, described as follows; to wit, Commencing at a point on the section line between Sections 14 and 23, Township 102 North, Range 40 West, lying directly North and 89 feet West of the Northeast corner of Lot 1, Block 1 of the Auditor's Plat of Benson's Addition to the City of Worthington in said County and State; thence North at right angles to the section line, a distance of 358 feet; thence West at right angles, 100 feet; thence South at right angles, 358 feet; thence East along said section line, 100 feet to the point of beginning.

Also, that tract of land located in the Southeast Quarter of the Southwest Quarter ($SW_{\pi}^{\perp}SW_{\pi}^{\perp}$) of Section 13, Township 102 North, Range 40 West, in the County of Nobles and State of Minnesota, described as beginning at the Southwest corner thereof; thence North on the section line, a distance of 250 feet; thence East and parallel to the South section line, a distance of 220 feet; thence South and parallel to the West section line, a distance of 250 feet to the South line thereof; thence West on said South section line, a distance of 250 feet to the South line thereof; thence West on said South section line, a distance of 220 feet to the place of beginning.
