AN ORDINANCE TO EXTEND THE BOUNDARIES OF THE VILLAGE OF SAUE RAPIDS AND INCORPORATE ADDITIONAL TERRITORY THEMSELVE

The Village council of Sauk Rapids does ordein:

Village Boundaries Extended. Pursuont to a petition duly signed by all of the owners of the land described as follows:

That certain real estate situate in the County of Benton, State of Minnesota, to-wit, that part of the Northwest one-Quarter (N.J. 1/4) of Section Twenty-three (23), Township Thirty-six (36), North, Range Thirty-one (31) West, to-wit:- Beginning at a point Thirty-three (33) feet East and One Mundred (100.0) feet south of the Northwest corner of said Sec. 23, T. 36, N.
