AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WINGER, MINDESCRA, TO INCIDE CEPTAIN PLATED LAND AND UNPLATED LAND NOT EXCREDING 200 ACTES IN AREA.

UEEEEAS, a certain petition dated October 20, 1955, requesting annexation of the territory described below and signed by all the owners of said territory was duly presented to the council on the 5 Th day of December, 1955;

The Council of the Village of Winger, Minneseta, ordains:

Section 1. Secleration. It is hereby determined that the territory described below abuts upon the village and is so conditioned as properly to be subjected to village government.

Section 2. <u>Territory Ammend</u>. The corporate limits of the village are hereby extended to include the territory described as follows:

Parcel I: Sicux Sub-division of part of the Northwest Quarter of Section 23 in Township 147 North, of Nange 42 West, of the Mifth Principal Meridian in Minnesota consisting of Lots 1 to 4 inclusive, and a highway and an alley as shown upon the plat and particularly described as follows:

* * * Beginning at the Southwest corner of said NV2, thence due North along the west boundary line of said Section 25, for a distance of 336 feet, thence due Mast along a line parallel with the south boundary line of said section for a distance of 5833 feet; thence due South along a line parallel with the wost boundary line of said section for a distance of 586 feet; thence due West along the south boundary line of said section for a distance of 586 feet; thence due West along the south boundary line of said section for a distance of 5985 feet to the place of beginning containing approximately 45 acres. *** *
