ORDINANCE NO. 263

AN ORDINANCE TO ANNEX CERTAIN PROPERTY TO THE CITY OF WORTHINGTON,
MINNESOTA

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW, WHEREAS, pursuant to Section 413.14 and all amendments thereto,
of Minnesota Statutes for 1941, all owners of property hereinafter
described and abutting upon the City of Worthington, have petitioned the
City Council of said City of Worthington to have such property annexed to
said City; and

WHEREAS it is desired that said territory become a part of said City
of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared
to be a part of the City of Worthington; to wit,

That part of the platted property known as North Worthington, lying in
the Southwest Quarter (SW $\frac{1}{4}$) of Section 13, Township 102 North, Range 40
West of the 5th P.M. in the County of Nobles and State of Minnesota,
described as follows:

The Westerly Nineteen and one-half (19 $\frac{1}{2}$) feet of Lot Four (4), all of
Lot Five (5), and the Easterly Fifty-eight and one-half (58 $\frac{1}{2}$) feet of Lot
Six (6), all in Block One (1) in said North Worthington, together with that
part of the public alley lying North of and abutting the said above
described property.
