

ORDINANCE NUMBER 36

AN ORDINANCE DETACHING AGRICULTURAL LANDS FROM THE VILLAGE OF REVERE

The Village Council of the Village of Revere, Minnesota, Ordains:

SECTION I: - The tracts or parcels of land lying and being in the Village of Revere, County of Redwood and State of Minnesota, described as follows, to-wit:

All that part of the West one-half ($W\frac{1}{2}$) of the Southwest Quarter ($SW\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-four (24) in Township One Hundred Nine (109) North, Range Thirty-eight (38) West, lying and being North of the right-of-way of Minnesota Trunk Highway No. Fourteen (14).

The East Ten (10) acres of the Southeast Quarter ($SE\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-three (23) in Township One Hundred Nine (109) North, Range Thirty-eight (38) West.

The East Twenty (20) acres of the Northeast Quarter ($NE\frac{1}{4}$) of Section Twenty-six (26) of Township One Hundred Nine (109) North, Range Thirty-eight (38) West.

The East Ten (10) acres of the Northeast Quarter ($NE\frac{1}{4}$) of the Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-six (26) in Township One Hundred Nine (109) North, Range Thirty-eight (38) West.

are unplatted land situated within the corporate limits of the Village of Revere but adjacent to the Village boundary and occupied and used solely for agricultural purposes and said tracts or parcels of land are hereby detached from the Village of Revere.

SECTION II: - As provided by the laws of the State of Minnesota, the said detached tracts or parcels of land shall be subject to taxation for the payment of interest and principal on all village bonded indebtedness outstanding at the time this Ordinance takes effect to the same extent as if they were still a part of the Village.

SECTION III: - This Ordinance shall be in full force and effect upon due publication and upon filing of one certified copy of this Ordinance in the office of the County Auditor of the County of Redwood, Minnesota, and one certified copy in the office of the Secretary of State of the State of Minnesota.
