AN ORDINANCE DETACHING AGRICULTURAL LANDS FROM THE VILLAGE OF REVERS

The Village Council of the Village of Rovere, Minnesota, Ordains:

SACTION I: - The tracts or parcels of land lying and being in the Village of Revere, County of Redwood and State of Minnesota, described as follows, to-wit:

All that part of the Vest one-half (We) of the Southwest Quarter (SWE) of the Southeast Quarter (SEE) of Section Tronty-four (24) in Township One Hundred Nine (109) North, Range Thirty-eight (36) West, Lying and being North of the right-of-way of Minnesota Trunk Highway No. Fourteen (14).

The East Ten (10) acres of the Southeast Quarter (SE) of the Southeast Quarter (SE) of Section Twenty-three (23) in Township One Mundred Nine (109) North, Renge Thirty-eight (38) West.

The East Eventy (20) acres of the Northeast Quarter (MEL) of Section Eventy-six (26) of Tourship One Hungred Nine (109) North. Range Thirty-eight (38) West.
