

ORDINANCE NUMBER 32

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF HALSTAD TO INCLUDE CERTAIN PLATTED AND UNPLATTED LANDS HEREINAFTER DESCRIBED, LOCATED IN THE NORTH HALF OF SECTION THIRTY IN HALSTAD TOWNSHIP, NORMAN COUNTY, STATE OF MINNESOTA.

WHEREAS, A certain Petition dated April 5, 1956, signed by a majority of the owners of the hereinafter described property, requesting the annexation of said territory, was duly presented to the Village Council on the 13th day of April, 1956, and whereas a Public Hearing on said proposed annexation was held by the Village Council on the 21st day of May, 1956, after thirty days posted Notice thereof as required by law;

The Village Council of Halstad, Minnesota, ordains:

Section 1. DECLARATION. It is hereby determined that the hereinafter described property, being partially platted and partially unplatted, does not exceed Two Hundred (200) Acres; that said territory is abutting on the Village of Halstad and is so conditioned as properly to be subjected to Village government; and that the annexation thereof will be to the best interests of the Village and of the territory affected.

Section 2. The corporate limits of the Village of Halstad are hereby extended to include the territory described as follows:

Beginning at the Northwest Corner of Lot Eight (8) of Block Four (4) of Peterson's Addition to the Village of Halstad, Norman County, Minnesota, thence Westerly, on the North line of Peterson's Addition extended westerly, One Hundred (100) feet; thence Southerly, parallel with the West line of Block Four of Peterson's Addition, to the North line of Section Thirty (30), Township One Hundred Forty-five (145), Range Forty-eight (48), Norman County, Minnesota; thence Westerly on the Section line to a point on said Section line which is Two Hundred (200) feet west of, and approximately Thirty-three (33) feet North of, the Northwest Corner of Lot Fourteen (14), Block Four (4), of the Original Townsite of the Village of Halstad; thence southerly, parallel to the West boundary of the original Townsite of Halstad, and two hundred (200) feet west thereof, to a point Three Hundred Forty (340) feet South and Two Hundred (200) feet west of the Southwest Corner of the Original Townsite of Halstad; thence Easterly, parallel to the South boundary of the Northwest Quarter (NW¹/₄) of the aforesaid Section Thirty, to a point where said line would intersect the East border of Block Nineteen (19), Original Townsite of Halstad, if said East border were extended Southerly; thence Southerly, along said extension southerly of the East border line of said Block Nineteen, to the South boundary of the Northwest Quarter (NW¹/₄) of said Section Thirty; thence East on the South border of said Northwest quarter of Section Thirty to the Center of Section Thirty (30); thence North to the Southeast Corner of the Original Townsite of the Village of Halstad; thence West on the South border of said Original Townsite to the Southwest corner of said Original Townsite; thence North on the West border of said Original Townsite to the Northwest Corner of said Original Townsite; thence East along the North boundary of said Original Townsite to a point where it intersects the West line of Lot Eight (8), Block Four (4), Peterson's Addition extended Southerly; thence Northerly to the point of beginning.

Section 3. FILING. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State, State of Minnesota, and in the office of the County Auditor of Norman County, Minnesota.

Section 4. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its publication and the filing of the certified copies as directed in Section 3.
