AN ORDINANCE ANNEXING CERTAIN LANDS TO
THE VILLAGE OF LINDSTROM

WHEREAS, a petition has been filed with the Village Council of the Village of Lindstrom, Chisago County, Minnesota, requesting the annexation of certain lands to said Village of Lindstrom, and

WHEREAS, the said petition has been signed by all of the owners of ^{the} ₆ proposed to be annexed, and

WHEREAS, the Village Council has determined that said annexation will be to the best interests of the said Village and of the territory affected,

THE VILLAGE COUNCIL OF THE VILLAGE OF LINDSTROM does ordain as follows:

Section 1. That the following described real estate, to-wit:

All that part of Lots One (1), Two (2), Three (3) and Four (4) in Block One (1) of Andrews Beach, as per plat thereof on file and of record in the Office of the Register of Deeds, Chisago County, Minnesota, which lies in Government Lot Eight (8), Township Thirty-four (34), Range Twenty (20);

All that part of Lot One (1) in Block Three (3) of Andrews Beach, according to the plat thereof on file and of record in the Office of the Register of Deeds in and for said County, described as follows, to-wit: Commencing at a point in the North line of Lot 1 in Block 3 of Andrews Beach, 185 feet westerly of the Northeast corner of said Lot 1, measured along said northerly line thereof; thence South 72 degrees West along the southerly line of Raymond Avenue, 185 feet to the northwest corner of said Lot 1; thence South along the West line of said Lot 1, 31 feet to the southwest corner thereof; thence South 79½ degrees East along the northerly line of Andrews Avenue, 179 feet; thence North parallel with the East line of said Lot 1, 120.8 feet to the place of beginning, containing 31/100 acre, excepting therefrom all that part thereof conveyed to the Town of Chisago Lake for road purposes, as described in Book 18 of Deeds, Page 289;

All that part of Raymond Avenue in Andrews Beach, according to the plat thereof on file and of record in the Office of the Register of Deeds in and for said County of Chisago, described in that certain Order of the District Court in and for said County and State, dated October 10, 1911, a certified copy of which was recorded in the Office of said Register of Deeds on October 12, 1911, in Book C of Miscellaneous Records, Page 250;

Lots Two (2) and Three (3) of Block Three (3) of Andrews Beach, as per plat thereof on file in the Office of said Register of Deeds, and all of Lot One (1), Block Three (3), said Andrews Beach, except that part thereof conveyed to Johanna Louise Glader as described in Book 24 of Deeds, Page 349 in said Register of Deeds' Office,

is hereby declared annexed to the said Village of Lindstrom.

Section 2. This Ordinance shall take effect immediately upon its passage and adoption.
