RESOLUTION NO. 11

RESOLUTION REQUESTING THAT AN ELECTION BE HELD ON THE QUESTION OF
ANNEXING CERTAIN TERRITORIES TO THE CITY OF WHITE BEAR LAKE, MINNESOTA

WHEREAS, a certain petition dated the 31st day of May, 1956, requesting that an election be held on the question of annexing certain territory described therein to the City of White Bear Lake, Minnesota, was duly presented to this Council on the 12th day of June, 1956; and,

WHEREAS, said petition is in proper form and it appears therefrom that the same was signed by the required number of legal voters and that the territory therein described contains 817 persons and is within one and one half miles of this City Limit; and,

WHEREAS, the territory proposed to be annexed is properly to be subjected to city government; and,

WHEREAS, this Council finds that annexation would be to the best interests of the City and of the territory to be annexed,

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of White Bear Lake, Ramsey County, Minnesota:

That an election is hereby called and directed to be held on the 25th day of June, 1956, at Leo P. Brown's Garage at which election all qualified voters residing within the territory described in said petition may vote for or against the annexation of said territory to the City of White Bear Lake; and the polls at said election shall be open from 8:00 A.M. o'clock of said day, until 8:00 P.M. o'clock of said day.

1. Mrs. E. L. Choate, Mrs. A. G. Smith, Mrs. E. L. Meade, all residing within said territory, are hereby appointed to be Judges of said election, and Mrs. C. J. Japs, Mrs. T. J. Joy, Mrs. B. J. Tomaszewski, are residing within said territory are hereby appointed to be alternate Judges at said election, and the Judges of said election shall conduct the election so far as practicable in accordance with the laws regulating the election of Township Officers.

2. That the City Clerk shall cause notice of said election to be given in the manner prescribed by law.

The foregoing resolution was offered by Cardinal and on his motion supported by Kulkey was declared carried on the following vote:

PETITION FOR ANNEXATION

to the

CITY OF WHITE BEAR LAKE, MINNESOTA

TO THE CITY OF WHITE BEAR LAKE:

We, the undersigned, residents and legal voters of the territory hereinafter described, hereby petition your council and request that you order an election on the question of annexing the territory hereinafter described to the City of White Bear Lake, Minnesota.

We further petition that your council fix a time and place where said election shall be held.

I.

That all of your petitioners are legal voters and residents of the territory hereinafter described, and each has resided continuously within said territory for at least two years, prior to the date of this petition.

II.

That none of the territory hereinafter described is now a part of any incorporated city or village.

III.

That the territory, which it is proposed to annex, contains a resident population of more than 75 persons and no part of the land is more than one and one half miles from the city limits of the City of White Bear Lake.

IV

All of said territory lies entirely within the County of Ramsey and the description of said land is as follows:

That part of the South 1/2 of Section 23, Township 30, Range 22, described as follows:

Commencing at a point on the South line of said Section 23 where it intersects with the center line of Trunk Highway 61; thence running in an Easterly direction along the South line of said Section 23 which is also the center line of County Road F, to the Southeast corner of said Section 23; thence running North along the East line of said Section 23, which is also the center line of East Avenue, to a point where the said line intersects with the center line of South Shore Boulevard, formerly known as Lakeview Avenue; thence running Westerly along the center line of South Shore Boulevard, (formerly known as Lakeview Avenue) to a point where the said center line intersects with the center line of White Bear Avenue, which was formerly known as Lake Phalen Road, and is now Trunk Highway 100; thence running Westerly along a line parallel with said South line of Section 23 to a point on the Shore of Goose Lake which is the boundary line or City Limits of White Bear Lake; thence running in a Southwesterly line along said City Limits line and shore line of Goose Lake to a point where it intersects with the center line of Trunk Highway 61; thence in a Southerly direction along the center line of Trunk Highway 61 to the place of beginning, excepting those parcels thereof which are now included within the City of White Bear Lake, all according to the United States Government survey thereof.

This area contains approximately 130 acres.

V.

That a census of the above territory was commenced on the
30th day of May, 1956, and was completed on the 31st day of May, 1956.

A copy of said census is attached hereto and made a part hereof.
