

Ordinance No. 77

AN ORDINANCE ADOPTED BY THE VILLAGE OF FOLEY,

THE VILLAGE COUNCIL OF THE VILLAGE OF FOLEY, MINNESOTA, DO ORDEA
AS FOLLOWS:

Section 1. That the Village boundaries of the Village of Foley
are hereby extended so as to include the following described parcels
of land situated upon said village, to-wit:

(a) That part of the West Half of the Southwest Quarter ($\frac{1}{4}$ of $\frac{1}{4}$) of
Section Twenty-Five (25), Township Thirty-Seven (37), Range Twenty-nine
(29), described as follows:

Beginning at a point 627 feet north and 163.8 feet east of the
southwest corner of said section; thence north and parallel with the west
line of said section a distance of 459.4 feet to the southerly line of
a Town (Cemetery) road; thence northeasterly along said south line of said
Town road a distance of 257.95 feet; thence south and parallel to the west
section line a distance of 632.3 feet; thence west and parallel to the
south line of said section a distance of 212 feet to the point of beginning,
also of record in the name of Donald J. Wildman.

(b) That part of the Southwest Quarter of the Southeast Quarter ($\frac{1}{4}$ of $\frac{1}{4}$)
of Section Twenty-Five (25), Township Thirty-Two (35), Range Twenty-nine
(29), described as follows:

Beginning at a point on the west line of said section 627 feet
north of the southwest corner of said section; thence north on said west
line of said section 279.5 feet; thence east and at right angles to last
line a distance of 149.5 feet; thence north and parallel with said west
line of said section a distance of 271.7 feet to the southerly line of a
Town (Cemetery) road; thence northeasterly along the south line of said Town
road a distance of 16.5 feet; thence south and parallel with the west line
of said section a distance of 459.4 feet; thence west and at right angles
to last line a distance of 163.8 feet to the point of beginning, also a strip of
land six feet by 1,044 feet in Section 26 along Easterly side of Block One, Foley's Second
Addition.

Also a strip of land six feet by 1,044 feet in Section 26 along Easterly side of Block One, Foley's Second
Addition, now of record in the names of Amalia Teuer
and William K. Teuer, wife and husband.
