PUBLISHED NOTICE
ORDINANCE FOR DETACHMENT
OF TERRITORY

The Village Council of Savage, Minnesota, do ordain as follows:

SECTION I.
 The property to be described in the following paragraph, being unplatted land situated within the corporate limits of the Village of Savage, may be and here is detached from the Village of Savage. The description of the property above mentioned is as follows to-wit:

SECTION II.
 That part of Section 31, Township 27 North, Range 24, West of the Fifth Principal Meridian, Scott County, Minnesota, described as follows:

Commencing at a point where the east line of First Avenue of Riverdale Township extended south intersects the south line of said Section 31; thence easterly 250 feet more or less to the west line of Elm Street; thence northerly along the west line of Elm Street 786 feet; thence westerly, along the north line of the land formerly described as Lots 6, 7, 8, 9, and 10 of the South half of Block 51 in the Village of Savage according to the plat filed September 15, 1900, in the office of the

Deeds of said County, a distance of 250 feet more or less to the easterly line of said First Avenue extended; thence southerly in a straight line to the point of beginning.

Also, that part of Sections 9 and 16, Township 115 North, Range 21 West, Scott County, Minnesota, described as follows:

Starting at a point where the West line of Elm Street in the Village of Savage extended southerly intersects the Easterly right-of-way line of the Minneapolis, Northfield and Southern Railway at a point 40 feet distant from the center line of track; thence North on the West line of Elm Street extended southerly, Nine Hundred Six (906) feet to the south line of Section 31, Township 27 North, Range 24, West of the Fifth Principal Meridian; thence West along the South line of said Section 31 to the point of intersection with the Easterly right-of-way line of the Minneapolis, Northfield and Southern Railway; thence Southerly along the said Easterly right-of-way line Forty (40) feet distance from the center line of track to the point of beginning.

SECTION III.
 The above described property, although now detached, shall be subject to taxation for the payment of interest, and principal, on all Village bonded indebtedness outstanding at the time of detachment to the same extent as if it were still a part of the Village.

SECTION IV.
 This Ordinance shall take effect from and after its passage, publication, and filing of one certified copy thereof, in the office of the County Auditor for Scott County, and another certified copy thereof in the office of the Secretary of State for the State of Minnesota.

Affidavit of Publication

L. John Suel being duly sworn, on oath says: that he is, and during all the times herein stated has been the Secretary of the Corporation, the publisher of the newspaper known as The Shakopee Valley News, and has full knowledge of the facts herein stated;

That immediately prior to the publication therein of the printed Ord. for Detachment of Territory Village of Savage hereto attached, said newspaper was printed and published in the City of Shakopee, in the County of Scott, State of Minnesota on Thursday of each week: that during all said time said newspaper has been printed in the English language from its known office of publication within the City of Shakopee from which it purports to be issued as above stated in newspaper format and in column and sheet form equivalent in space to at least 450 running inches of single column, two inches wide; has been issued once each week from a known office established in said place of publication and employing skilled workmen and equipped with the necessary material for preparing and printing the same, and the presswork on that part of the newspaper devoted to local news of the community which it purports to serve, was done in its known office of publication;

That during all said time in its makeup not less than twenty-five per cent of its news columns have been devoted to local news of interest to the community it purports to serve, that during all said time it has not wholly duplicated any other publication, and has not been entirely made up of patents, plate matter and advertisements; has been circulated in and near its said place of publication to the extent of at least two hundred and forty (240) copies regularly delivered to paying subscribers and has entry as second class matter in its local postoffice; that the said newspaper was in existence but publication thereof was suspended before the completion of one full year because the editor or publisher entered active military service after December 7, 1941, and prior to December 31, 1946, under the Selective Service Act of 1940, and publication of the newspaper was resumed after honorable discharge of the editor or publisher; and that there has been on file in the office of the County Auditor of Scott County, Minnesota the affidavit of a person having knowledge of the facts, showing the name and location of said newspaper and the existence of the conditions constituting its qualifications as a legal newspaper.

That the Ord. for Detachment of Territory Village of Savage attached was cut from the columns of said newspaper, and was printed and published therein in the English language, once each week, for one successive weeks; that it was first so published on Thursday, the 31 day of May 1956 and thereafter on Thursday of each week to and including the day of 195.....; and that the following is a printed copy of the lower case alphabet from A to Z, both inclusive, and is hereby acknowledged as being the size and kind of type used in the composition and publication of said notice, to-wit:
