set forth a correct figure for the total population of the terri-
tory described in the foregoing petition and,

WHEREAS, Based upon the census as originally prepared and
filed, the undersigned prepared and signed their petition above
mentioned, stating the resident population of the area to be
1689 persons and,

WHEREAS, The said Melvin H. Clark, J. S. VonWald
and F. A. Emanuelson have now executed a supplement to
their said census, disclosing the total population of the said area
as of the date of taking the said census, March 10, 1956 to June 14, 1956,
to have been 1688.

NOW THEREFORE, The undersigned, for the purposes of remedying
a clerical error in the preparation of the "Petition for Incorpora-
tion of VILLAGE OF BABBITT, MINNESOTA" dated August 9, 1956,
and conforming the said petition to the facts, do hereby amend para-

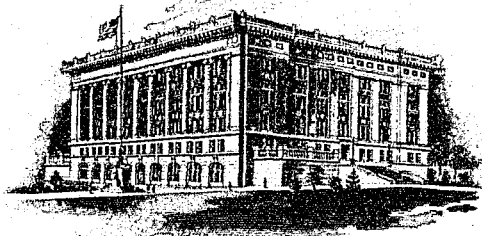

PETITION FOR INCORPORATION

TO THE BOARD OF COUNTY COMMISSIONERS
OF THE COUNTY OF ST. LOUIS MINNESOTA:

We, the undersigned, residents of the territory hereinafter described, hereby petition your Honorable Board to fix a time and place when and where the resident legal voters within said territory may vote on the question of incorporating the same as a village, pursuant to Laws of Minnesota, 1955, Chapter 390 and Minnesota Statutes 1953, Chapter 412, and for that purpose respectfully state:

1. That the Town of Argo is an organized Town and has a population of more than 500 persons and a platted area on which at least half of the population of the Town resides.

2. That the said Town of Argo contains within its limits both lands containing taconite as described in Minnesota Statutes 1953, Section 294.23, and a plant or plants for the concentration of taconite, either under construction or in operation.

3. That all of your petitioners are qualified voters and residents within the territory hereinafter described, and each has resided continuously within said territory for at least one year prior to the date of this petition.

4. That none of the territory hereinafter described is now a part of any incorporated City or Village.

5. That the territory which it is proposed to incorporate consists partly of lands which have been platted into lots and blocks, which plat or plats have been duly and legally made and certified according to the laws of this State and are filed in the office of the Register of Deeds, in and for St. Louis County, Minnesota, and partly of unplatted lands which adjoin the platted area and are so conditioned as properly to be subjected to village government. All of said lands, platted and unplatted, lie entirely within the County of St. Louis, Minnesota, and the description of

said lands both platted and unplatted, is as follows: All of the land in the Town of Argo, St. Louis County, Minnesota.

6. The boundaries of the foregoing lands are as follows:

The North boundary line is the North line of Township 60 Range 13 and the North line of Township 60 Range 12; the East boundary line is the East line of Township 60 Range 12 and the East line of Township 59 Range 13; the South boundary line is the South line of Township 60 Range 12 and the South line of Township 59 Range 13; the West boundary line is the West line of Township 59 Range 13 and the West line of Township 60 Range 13.

7. The quantity of land, both platted and unplatted, embraced within the foregoing description is 69,120 acres, be the same more or less.

8. The foregoing lands, both platted and unplatted, and bounded as described contain a resident population of 1689 persons, as ascertained by a census which was commenced on the 10th day of March 1956, and completed on the 14th day of June, 1956, a copy of which is attached hereto and made a part hereof.

9. The name of the village proposed to be incorporated is the Village of Babbitt, Minnesota.

Your petitioners also request that at the time and place and at the same election the following question be submitted to the qualified voters residing within said territory:

"Shall Optional Plan A, modifying the standard plan of village government by providing for the appointment by the council of the Clerk, Treasurer and Assessor, be adopted for the government of the village if the village is incorporated?"




