ORDINANCE # 4\
An ordinance to extend
the Boundaries of Young America
and Incorporate additional
territory therein.

The Village Council of the Village of Young America, Minn., do ordain:

Section 1 - <u>Village Boundary Extended</u>: Pursuant to a petition duly signed by Harold C. Smith and Cordelia V. Smith, the owners of the land described as follows, to-wit:

That part of the Northwest Quarter of Southeast Quarter of Section 11, Township 115 North, Range 26 West, described as follows:

Commencing at the Northwest corner of said Northwest Charter of Southeast Charter; thence South on the West line of said Northwest Quarter of Southeast Charter, a distance of 11.65 KKK chains; (768.9 feet), thence South 67 Teast a distance of 549.22 feet; thence Northeasterly on the Westerly right of way line of Trunk Highways #5 and 25, on a center line curve of 130', delta angle of 213' to the left a distance of 524.3 feet to a point 477.2 feet South of the North line of said Northwest Charter of Southeast Charter; thence West and parallel with said North line a distance of 108.78 feet; thence North and parallel with the West line of said Northwest Charter of Southeast Charter, a distance of 477.2 feet to the said North line; thence West on said North line a distance of 497.08 feet to the place of beginning.
