

ORDINANCE NO. 19

AN ORDINANCE RELATING TO THE DETACHMENT OF CERTAIN  
TERRITORY FROM THE VILLAGE OF GREENWOOD, MINNESOTA

The Village Council of the Village of Greenwood, Minnesota,  
ordains:

SECTION 1. DETACHMENT. That the land hereinafter described  
in Section II hereof, pursuant to MINNESOTA STATUTES ANNOTED 412.061,  
is hereby detached from the Village of Greenwood, Minnesota, pur-  
suant to petition of the sole owner of said land.

SECTION 2. DESCRIPTION OF LAND DETACHED. That the land hereby  
detached is situated in Hennepin County, Minnesota, and is described  
as follows, to-wit:

Those parts of Tracts E and F, Registered Land Survey  
No. 593, Hennepin County, Minnesota, now within the limits  
of the Village of Greenwood, Minnesota.

SECTION 3. CERTIFIED COPIES TO BE FILED. The Clerk is hereby  
directed to file certified copies of this ordinance in the office  
of the Auditor of Hennepin County and in the office of the Secretary  
of State of the State of Minnesota.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect  
and be in force from and after its passage and publication and the  
filing of said certified copies aforesaid, but not before the  
council of the Village of Excelsior, Minnesota, has adopted an  
ordinance annexing the said land to it.
