ORDINANCE NO. 1.10

AN ORDINANCE RELATING TO THE AMMERATION OF CERTAIN TERRITORY TO THE VILLAGE OF EXCELSIOR, MINNESOTA

The Village Council of the Village of Excelsior, Minnesota, ordains:

SECTION 1. ANNEXATION. That the land hereinafter described in Section 2 hereof, the Village Council having determined that the annoxation thereof is to the best interests of the village and to the territory affected, is hereby annexed to and included within the boundaries of the Village of Excelsior pursuant to petition of the sole owner of said land and after considering the matter pursuant to MINNESOTA STATUTES ANNOTED 412.061.

SECTION 2. DESCRIPTION OF LAND ANNEXED. That the land hereby annexed is situated in Hennepin County, Minnesota, and is described as follows, to-wit:

Those parts of Tracts I and F, Registered Land Survey No. 593, Hennepin County, Minnesota, now within the Village of Greenwood, Minnesota.

SECTION 3. CERTIFIED COPIES TO BE FILED. The Clerk is hereby directed to file certified oppies of this ordinance in the office of the Auditor of Hennepin County and in the office of the Secretary of State of the State of Hinnesota.

SECTION 4. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its passage and publication and the filing of said certified copies aforesaid.
