

TO THE HONORABLE BOARD OF COMMISSIONERS  
OF THE COUNTY OF CROW WING, MINNESOTA:

The undersigned respectfully petition your honorable board to call an election pursuant to law for the determination of the proposed incorporation of a Village to be known as Village of Emily and respectfully state and petition as follows:

That they are voters who have resided within the territory to be incorporated for at least two (2) years prior to the date hereof.

That the territory to be incorporated is that presently described as the Township of Emily in Crow Wing County, Minnesota.

That such territory is not now included within the limits of any incorporated municipality.

That such territory includes land which has been plotted into lots and blocks as provided by law and also includes unplatting lands adjoining such plotted areas, which unplatting lands are so conditioned as properly to be subjected to village government.

That such platted lands are described as follows, to wit:

Original Town of Emily, consisting of four (4) blocks, each containing twelve (12) lots;  
Andrews Addition to Emily, consisting of one (1) block containing twelve (12) lots;  
Crockett Shores, consisting of forty-four (44) lots;

The First Addition to Crockett Shores, consisting of twenty-seven (27) lots;  
New Emily, consisting of twelve (12) blocks and three hundred forty-six (346) lots;  
Auditor's Subdivision of the Southeast Quarter of Southwest Quarter (SE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Twenty Seven (27);

Outing, consisting of four (4) blocks and forty-one (41) lots;

Andrews Addition to Outing, consisting of eleven (11) lots;

Ruth Lake Paradise Shores, consisting of twenty-two (22) lots;

Clearwater Beach, consisting of twenty (20) lots;

Ogema Beach, consisting of thirty-one (31) lots;  
First Addition to Ogema Beach, consisting of nineteen  
(19) lots;  
Pinehurst, consisting of one hundred eleven (111) lots;  
First Addition to Ruth Lake Paradise, consisting of  
seventeen (17) lots;  
Trout Lake Park, consisting of thirty (30) lots;  
Fletcher's Addition to Clearwater Beach, consisting  
of Twelve (12) lots;  
Anderson's Norway Beach, consisting of eleven (11) lots;  
Bloomquist's Addition to Emily, consisting of thirty-  
one (31) lots;  
Starry's Murmuring Pines, consisting of nine (9) lots;  
Kavli's Woodlake Shores, consisting of ninety-nine (99)  
lots;  
Linda Park, consisting of thirteen (13) lots.

That the boundaries of the territory to be incorporated  
are identical and coexistent with the boundaries of Emily Town-  
ship, Crow Wing County, Minnesota, and embrace said entire town-  
ship.

That the number of actual residents within said territory  
is three hundred ninety-five (395).

That the proposed name of the village is "Village of Emily."

That a census of the resident population of the area pro-  
posed to be incorporated has been taken and that the number and  
names of such residents together with the number of buildings in  
said area used for residents and the number and names of the  
residents in each are set forth in such census which is attached  
hereto, marked Exhibit A and made a part hereof by reference.

That such census was taken between December 1 and December  
3, 1956, both dates inclusive.
