

ORDINANCE NO. 39

AN ORDINANCE ANNEXING TO THE VILLAGE OF ST. ANTHONY CERTAIN LANDS IN RAMSEY COUNTY.

WHEREAS a petition requesting annexation to the Village of St. Anthony of certain lands in Ramsey County has been presented to and filed with the Village, which lands are as described herein below; and said petition has been made and signed by all the owners of said lands; and said lands are unplatted and do not exceed in their total area the sum of 200 acres; and said lands are suburban and abut upon the Village of St. Anthony, and are not included in any other village, or in any city or borough, and are so conditioned as properly to be subjected to village government; and said lands have a natural connection as well as a unity of interest with this village, and annexation of said land by the Village is deemed to be in the best interests of the Village and of said lands,

NOW, THEREFORE, THE VILLAGE COUNCIL OF ST. ANTHONY DO ORDAIN AS FOLLOWS:

SECTION 1. That pursuant to Minnesota Statutes 1955, Sec. 412.041, there is hereby annexed, attached to and made a part of the Village of St. Anthony that land lying in the County of Ramsey, which abuts the Village on its north boundary limits (the center line of 37th Avenue N.E., Ramsey County Road "D") and lies north of the center line of 37th Avenue N.E. (Ramsey County Road "D"), south of the center line of Lake View Drive, east of the center line of Stinson Boulevard and west of the center line of Silver Lake Road. All of said land being part of and located within Section Thirty-one (Sec.31), Township Thirty North (T.30N), Range Twenty-three West (R.23W), and comprised of the following parcels thereof:

- (a) All of the Southeast Quarter of the Southwest Quarter ($SE\frac{1}{4}$ of $SW\frac{1}{4}$) thereof
- (b) All of the Southwest Quarter of the Southwest Quarter ($SW\frac{1}{4}$ of $SW\frac{1}{4}$) thereof
- (c) That part of the Northeast Quarter of the Southwest Quarter ($NE\frac{1}{4}$ of $SW\frac{1}{4}$) thereof lying southerly of the center line of Lake View Drive.
- (d) That part of the Northwest Quarter of the Southwest Quarter ($NW\frac{1}{4}$ of $SW\frac{1}{4}$) thereof, lying southerly of the center line of Lake View Drive.

SECTION 2. That this ordinance shall be in force and effect from and after its publication.

SECTION 3. The Village Clerk is hereby authorized and directed upon publication of this ordinance to file a certified copy hereof in the office of the County Auditor in and for the County of Ramsey and also to file a certified copy hereof in the office of the Secretary of State of the State of Minnesota.

SECTION 4. That upon such publication and the filing of a certified copy of this ordinance in the office of the County Auditor, and in the office of the Secretary of State the annexation shall be complete and the land herein above described shall become a part of the Village of St. Anthony as effectual as if it had been originally a part of said Village.

- (a) All of the Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) thereof
- (b) All of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) thereof
- (c) That part of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) thereof lying southerly of the center line of Lake View Drive.
- (d) That part of the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$) thereof lying southerly of the center line of Lake View Drive.

Section 2. That this ordinance shall be in force and effect from and after its publication.

Section 3. The Village Clerk is hereby authorized and directed upon publication of this ordinance to file a certified copy hereof in the office of the County Auditor in and for the County of Ramsey and also to file a certified copy hereof in the office of the Secretary of State of the State of Minnesota.
