

ORDINANCE NO. 273

AN ORDINANCE TO AMEND CERTAIN PROVISIONS TO THE CHARTER OF THE CITY OF WORTHINGTON, MINNESOTA.

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAIN:

NOW, WHEREAS, pursuant to Section 413.24, and all amendments thereto, of Minnesota Statutes for 1941, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City; and

WHEREAS, it is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to-wit:

That part of the Northeast Quarter (NE 1/4) of Section 28, Township 102 North, Range 10 West of the 5th P.M., in the County of Nobles and State of Minnesota, bounded and described as follows, to-wit: Commencing at the Northwest corner of said quarter section and thence running east on the North line of said quarter section a distance of 1031.5 feet; thence running south at right angles a distance of 2512.7 feet to the Northeastly line of the established public road running over said land and known as Liberty Drive on the plat of Cherry Point Park, which plat was filed for record in the office of the Register of Deeds in and for Nobles County, Minnesota, on October 7, 1918, at 12:00 o'clock P.M., thence running Northeastly along said Northeastly line of said public road a distance of 1250.5 feet to the West line of said Quarter Section; thence running north on said West line a distance of 1825.5 feet to the place of beginning, according to the plat and survey thereof made by the County Surveyor of Nobles County, Minnesota, on March 1, 1924, and which plat and survey is recorded in the Surveyor's Record "B" on page 139 in the Office of the Register of Deeds in and for said County and State, said tract containing 51.74 acres more or less.
