



ORDINANCE NO. 275

AN ORDINANCE TO ANEX CERTAIN PROPERTY TO THE CITY OF WORTHINGTON,
MINNESOTA,

THE CITY COUNCIL OF THE CITY OF WORTHINGTON, DO ORDAINE:

NOW, WHEREAS, Pursuant to Section 413.14, and all amendments thereto, of Minnesota Statutes for 1941, all owners of property hereinafter described and abutting upon the City of Worthington, have petitioned the City Council of said City of Worthington to have such property annexed to said City; and

WHEREAS, It is desired that said territory become a part of said City of Worthington, the same as if it had been originally a part thereof;

NOW, THEREFORE, The following described territory is hereby declared to be a part of the City of Worthington; to-wit,

A tract of land in Government Lot 6 in Section 26, Township 102 North, Range 40 West of the 5th P.M., in the County of Nobles and State of Minnesota, described as follows: Commencing at the Norander corner of West Chabena Lake on the section line between Sections 26 and 27, Township 102 North, Range 40 West, thence south on the section line a distance of 119 feet to the northerly line of the County Highway, now known as South Shore Drive, thence in an easterly direction along the northerly line of the highway a distance of 362.2 feet, thence south a distance of 83.8 feet to the southerly line of the County Highway, which is the point of beginning; thence in an easterly direction along the southerly line of the highway a distance of 123 feet; thence south on the line between Lots "C" and "D" of "Ludlow's Subdivision of that part of U. S. Government Lots 6 and 7 in Section 26, Township 102 North, Range 40 West, North of the C. St. P. R. R. Railway Company Right of Way" as recorded on Page 140 Book "B" Surveyor's records of Nobles County, Minnesota, a distance of 300 feet, thence west a distance of 123 feet; thence north a distance of 277 feet to the point of beginning.
