

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE VILLAGE OF COOK

WHEREAS, The following described properties are immediately adjacent to the existing boundary limits of the Village of Cook, and

WHEREAS, The owners of said land have petitioned to have the same annexed to the Village of Cook, and

WHEREAS, The Village Council of the Village of Cook has determined that it is for the best interests of the Village of Cook to annex said lands,

NOW THEREFORE THE VILLAGE OF COOK DO ORDAIN:

Section 1: The following described properties are hereby annexed to the Village of Cook and are hereby made a part of the Village of Cook, the owners thereof having duly petitioned to have the same annexed:

The North 460 feet of the West 427 feet of the NE $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 18, Township 62, Range 18, County of St. Louis, State of Minnesota, and

All that part of the Plat of SUNRISE, lying outside of the existing limits of the Village of Cook, said plat having been platted over a portion of the NW $\frac{1}{4}$ of SE $\frac{1}{4}$, Section 18, Township 62, Range 18, and being recorded in the Office of the Register of Deeds in and for the County of St. Louis, State of Minnesota, in Book C-1 of Plats, Page 40, and which plat is hereby approved and accepted as part of the Village of Cook. The portion of said plat lying outside the Village and which is hereby annexed includes the following: All of Blocks 2, 4, and 6; a portion of Lots 4 and 5, Block 1; a portion of Lots 5 and 6, Block 3; a portion of Lots 3 and 4, Block 5; a portion of Lot 2, and all of Lots 3, 4, 5, 6, 7, 8, 9, and 10, Block 7, and Outlot A, SUNRISE.

Section 2: This Ordinance shall take effect and be in force from and after its passage and publication.




