2 CERTIFICATE OF AMENDMENT TO THE  
3 CHARTER OF THE CITY OF  
4 FARIBAULT

5 I, Frank H. Duncan, Mayor of the City of Faribault in the  
6 County of Rice and State of Minnesota, do hereby certify:

7 1. On the 1st day of March, 1957, the Board of Freeholders of  
8 said City duly submitted to me the following proposed amendments  
9 to the Charter of the City of Faribault:

10 AMENDMENT NO. 1

11 The Council, in the first instance, shall on its own motion or  
12 may, on the recommendation or report of any department or officer  
13 of the city, determine in a general way the commodities, labor,  
14 service to be done or furnished, and shall estimate the cost  
15 thereof, and in order to determine such estimated cost may re-  
16 quire estimates from any officer or employee of the city. In  
17 case such estimated cost does not exceed the sum of one thousand  
18 dollars, the Council may direct that the commodities, labor or  
19 service be procured by or through the proper department or offi-  
20 cer of the city without bids. Except as hereafter mentioned,  
21 where such estimated cost exceeds the sum of one thousand dollars  
22 said commodities or service shall be furnished or done upon  
23 public bids and under contract.

18 AMENDMENT NO. 2

19 Subject to applicable statutes and to additional regulations  
20 provided by ordinance or council resolution not inconsistent  
21 therewith the council shall at least once a year designate one  
22 or more depositories in the City of Faribault, in which the City  
23 Treasurer shall deposit city funds as soon as received.

22 2. That pursuant to the constitution and Laws of said State,  
23 said proposed amendment was published once a week for four (4)  
24 successive weeks in the Faribault Daily News, a newspaper of  
25 general circulation in said City and all other steps as required  
26 by law were duly taken to bring the proposed amendments to a  
27 vote of the electors of said City.

28 3. That said proposed amendments were duly submitted for adopt-  
29 ion or rejection of the electors of said City at the election  
30 held on the 2nd day of April, 1957.

31 4. That from the official canvass of the votes cast at the said  
32 election for and against the aforesaid proposed amendments made  
33 in conformity with the law, it appears that more than three-fifths

of all electors voting at such election voted for the adoption of such proposed amendment.

That this certificate is made by me by virtue of the authority vested in me as Mayor of the City of Faribault and in compliance with law, and to certify that aforesaid proposed amendment to the Charter of said City has been duly ratified and adopted as prescribed by the constitution and Laws of the State.
