

ORDINANCE NO. 81

AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE VILLAGE OF WAITE PARK TO INCLUDE
CERTAIN PLATTED LAND

WHEREAS, a certain petition dated March 5, 1957, requesting annexation of the territory described below was duly presented to the council on the 5th day of March, 1957.

The Council of the Village of Waite Park, Minnesota ordains:

Section 1. Declaration. It is hereby determined that the territory described below abuts upon the Village and is so conditioned as properly to be subjected to village government.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the territory described as follows:

Lot Three (3) and the West One-half of Lot Four (4), Block Two (2), Waite Park Acres an Addition in the Township of St. Cloud, Stearns County, Minnesota according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for Stearns, Minnesota.

Section 3. Filing. The Village Clerk is hereby directed to file certified copies of this ordinance in the office of the Secretary of State and in the office of the County Auditor of Stearns County, Minnesota.

Section 4. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 2.
