ORDINANCE NO. 61

AN ORDINANCE PROVIDING FOR ADDITION OF TERRITORY TO THE VILLAGE OF SPRING VALLEY.

THE VILLAGE COUNCIL OF THE VILLAGE OF SPRING VALLEY, MINNESOTA DO ORDAIN AS FOLLOWS:

A petition having been filed in accordance with the provisions of Minnesota Statutes Annotated Section 412.061, sub-section 4 thereof, it is hereby determined that the annexation of the following described property located in the County of Fillmore, State of Minnesota, to-wit:

Commencing at the Southwest (SW) corner of the Southeast Quarter of the Northwest Quarter (NW^{1/4} NW^{1/4}), in Section Twenty Seven (27), Township One hundred three (103), Range Thirteen (13), thence North nine hundred fifty (950) feet, thence East Nine hundred fifty (950) feet, thence South Nine hundred fifty (950) feet, thence Nine hundred fifty (950) feet to the place of beginning, containing 20.72 acres,

to and will be for the best interest of the Village and of the Territory affected and it is hereby declared that such land be annexed to the Village of Spring Valley, Minnesota.

This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
