

Ordinance No. 48

AN ORDINANCE DETACHING LAND FROM THE VILLAGE OF  
ISLE, MINNESOTA

THE VILLAGE COUNCIL OF THE VILLAGE OF ISLE, MINNESOTA, ORDAINS AS  
FOLLOWS:

1. It is hereby found and determined that petitions have been received from the owners of land situated within the Village for the detachment of such land from the Village, the land described in said petitions being as follows:

All lands in Section 4 and 5, T 42, R 25, Mille Lacs County now located in the Village of Isle lying North and West of the following described line: Having as its beginning, a point on the shoreline of Lake Mille Lacs between Gov. lot 5, Sec. 4, T 42, R 25, and Gov. lot 1, Sec. 5, T 42, R 25. Thence running east to the SE corner of the SE of the SW, of Sec. 4, T 42, R 25. Thence running north 40 rods, more or less, to the NE corner of the SE of the SW Sec. 4, T 42, R 25. Thence running east 40 rods, more or less, to the SE corner of the NW of the SE of Sec. 4, T 42, R 25. Thence running north to a point on the shoreline of Lake Mille Lacs between Gov. lot 2 and Gov. lot 1 in Sec. 4, T 42, R 25. Also all tracts of land in Gov. lot 1, Sec. 5, T 42, R 25.

2. The above described land is hereby detached from the Village of Isle and attached to the Town of Isle Harbor.

3. This ordinance shall be in full force and effect upon its publication in the official newspaper of the Village and filing of certified copies of this ordinance in the office of the County Auditor of Mille Lacs County and the office of the Secretary of State of the State of Minnesota.
