RESOLUTION

WHEREAS; legislation has been enacted by the State of Minnesota authorizing the Board of County Commissioners in certain counties to assign or attach any Unorganized Territory to any existing Township, Village or City within the County.

AND WHEREAS; the original Township of Fridley by incorporation and annexation into other political subdivisions left such a small territory and valuation remaining that it became necessary for the County Board to dissolve the Township and declared the remaining territory as Unorganized.

NOW THEREFORE BE IT RESOLVED; that the Unorganized Territory described as follows: Sheffield's 1st Subdivision known as SE $\frac{1}{4}$ of SW $\frac{1}{4}$ of Section 25, Township 30, Range 24 and the SW $\frac{1}{4}$ of NE $\frac{1}{4}$, the North 20 acres of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ and the South 20 acres of North $\frac{1}{2}$ of NE $\frac{1}{4}$ all in Section 25, Township 30, Range 24, be hereby assigned and attached to the City of Columbia Heights and that the assets applying to the territory be distributed and transferred to the City of Columbia Heights according to law.


Kordiak made motion that the Resolution be adopted. Johnson seconded the motion, all voting "Yes". Motion declared adopted.
